

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to 3901 NW 79th Ave, Ste 245 #3539, and Go Digital Hero LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Go Digital Hero LLC include 3901 NW 79th Ave, Ste 245 #3539 and GDH. The GDH website is a News and Information site. By using the GDH website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, GDH may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. All such third parties are prohibited from using your personal information except to provide these services to GDH, and they are required to maintain the confidentiality of your information.

GDH may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on GDH or the site; (b) protect and defend the rights or property of

GDH; and/or (c) act under exigent circumstances to protect the personal safety of users of GDH, or the public.

Tracking User Behavior

Automatically Collected Information

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on

- your relationship with us;
- Comply with an existing legal obligation; or
 - Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen

GDH does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
